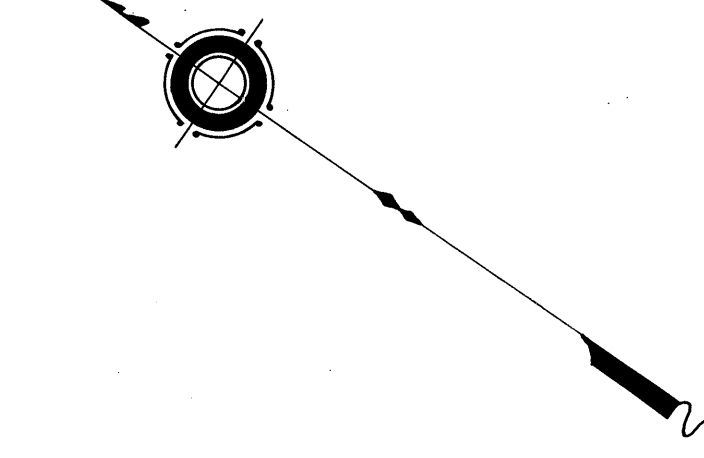


NOTE: the boundry courses of rectangular are the same as the boundary courses of the blocks.

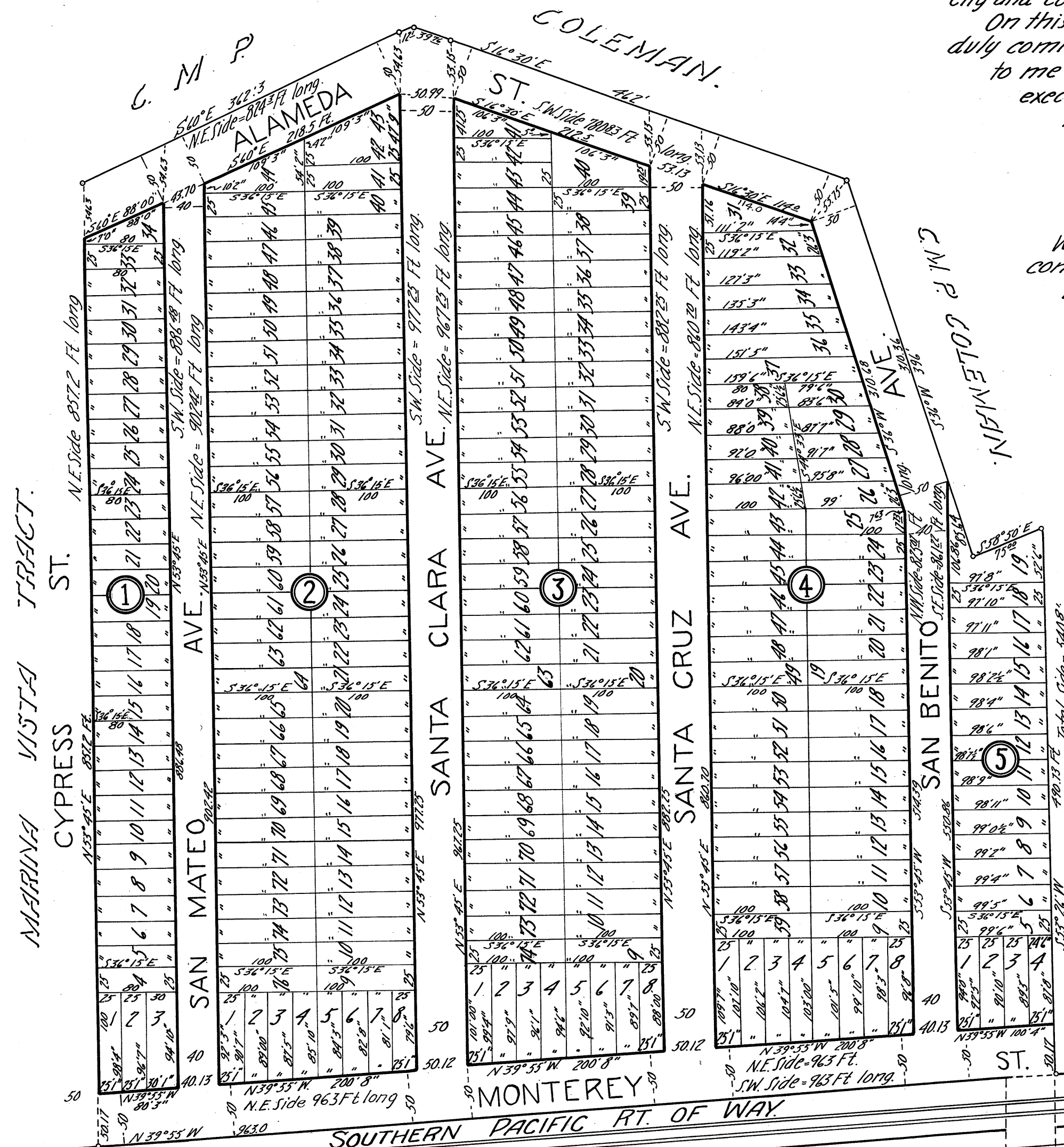
